Pursuant to a letter of agreement with District Council 37, Local 983 (hereinafter referred to as “Local 983”), the American Arbitration Association, hereinafter referred to as the “Administrator”, agreed to conduct an Election of Officers via Online, Telephonic and In-Person Online Voting.

Two Thousand Three Hundred Ninety (2,390) voting instructions were mailed to eligible voters on Thursday, April 27, 2023. District Council 37 provided the list of members eligible to vote. 
